Mayor Riley read his state of the city address.

Mayor Riley informed the council he had information on police salaries in the area.

The Mayor said he would be meeting with someone who could redraw the city zones, addressing the issue of placement of manufactured homes in the city limits. The cost of the work will be \$2,000.00.

Kim Morgan, director of the Senior Life Center, said St. Bernard's had cut her hours of work and has inquired about getting some help with cleaning at the building.

Roger Williams gave a report on the Caraway Volunteer group delivering sixty three food baskets and gave toys to seventy eight children during the recent Christmas season.

Mayor Riley said that Title work was still being done on the Masonic Lodge building.

Trash pickup has been late the last couple of weeks.

Areas in the city mentioned for cleanup included: South New York, the old dress factory, property on Kentucky, State street and Main street. Police Chief Shannon Kelems reported on the progress made on these properties.

Bo James informed the council that four of the new apartments will be ready in a couple of weeks, with the other four being reading in February.

Bo James also announced that the Make-A-Wish road block would be Friday, February 16th.

Mayor Riley introduced new police officer David Choate, and informed the council that Dylan Wilmoth be going to the Police Academy next week.

Mayor Riley also stated that Water Supt. Terry Couch has Ryan Kelems working part-time in the water department.
