Water Superintendent Terry Couch reviewed the status of the city's water well. It was the opinion of Terry that it is very possible that the only fix will be that a new well will have to be put down. Prices for the work was discussed with a possible cost of \$200,000 to \$500,000.00. Various financing arrangements were discussed. Couch said the city is in a state of emergency at the present time.

Water Superintendent Terry Couch informed the council of a leak in the city water tank and that it would take some welding and other work to fix it.

The council was made aware of a bill for \$20,481.07 due to be paid to Jones Hydro Services for work they have done on checking out the city well.

Jerry Martin made a motion for the city to pay Jones Hydro Services \$20,481.07 for work done on the city well to find what is wrong with it and possible solutions to fix it. Second by Bo James.

The determination of job priorities performed by city employees.

Old vehicles that may be out of compliance with city ordinance codes and should be moved.

The air conditioner unit used by the police department needs the leafs cleaned out from around it.
