Other items discussed by the council included:

Mayor Riley informed the council on check numbers from the check books of the formally used Heritage Bank city accounts. The old Heritage Bank checks that are left will be destroyed with the city's transition to Arvest Bank.

Mitchell Tipton suggested the city host a public meeting to inform the citizens of the city's options concerning the financing of a new city well.

Options include borrowing the money with increased water rates or passing a city two cent sales tax.

One cent going toward the water well and other cent set aside.

The meeting date is planned for Monday, November 26th, when the details for the meeting are finalized the public will be informed.

Mitchell Tipton informed the council of some landowners on Payne Street being opposed to the possibility of rent houses being built on the newly purchased properties. Mayor Riley said the builder had not come to the city with any plans as of yet.

An issue of voting privileges for a city resident on Cemetery road was discussed and Mayor Riley said he would look into the matter.

Roger Williams announced that the Caraway Christmas Parade will be Saturday, December 1st beginning with the line up at city hall at 5;30 p.m. The parade will start at 6:00 p.m. The parade will be dedicated in memory of Melton Emery. Toys and food will be collected to be given away during the Christmas holidays.

Bo James reported that the new grocery store would open Monday, November 12th. Ground breaking on some new apartments will be held soon also.

Mayor Riley handed out to the city council a proposed budget for 2019 to look at and discuss at the December meeting. The deadline for approval of the 2019 city budget is January 31st.

Roger Williams made a motion to adjourn meeting, seconded by John Boatman. Motion carries on vote of 6-0.
