The city trailer ordinance will also be presented to the council for approval with some minor additions at next month's council meeting.

Mayor James gave the meeting floor to Robert Gross to address the council about his water bill.

Mayor James read a letter from A.N.R.C. to inform the city of their recommendation for Caraway for a loan in the amount of \$527,000.00 to be used for the digging of the new city well being considered. The loan would be for 20 years at 2.5 interest. The city must send a letter in by June 25th to meet the deadline. The mayor informed the council that this is very early in the process.

More new apartments are being built on Missouri street in what will be known as Park Place Apartments. Refurbished light poles and lights will be added to the property for enhanced appearance of the property.

Police Chief Shannon Kelems reported he and the police department are continuing to work to get all residential property in compliance with the city's ordinance. Citations have been served and will be if needed to get all in compliance.

New lights have been put up on the north end of the city cemetery to provide more light at night.

Roger Williams thanked volunteers for work on the city monument, city park bandstand and encouraged everyone to come out and support the Caraway July 4th celebration.

Fireworks will be shot at approximately 9:00 p.m. that night.
