The council tabled the issues of handling employee comp. time and gas & plumbing inspections.

The city mobile home ordinance was briefly discussed with no action taken at this time.

Mayor James gave updates on the street paving that is being planned for provided funding is received.

noles to be repaired, properties needing cleaned up, a tree being needed moved out of an alley behind the Methodist church, moving playground equipment at the back ball park, and repairing of the roof at the old factory building were discussed. Mayor James said he would see that this issues were taken care of.

New windows have been ordered for the old factory building and will soon be installed.

Mayor James reported that the members of the Caraway Veteran's Memorial committee have given up the management of the memorial to the city.

Mayor James informed the council that the Arkansas Legislative Audio Dept. had finished the city audit with no reportable findings. The Mayor also said the Caraway Park Commission must have an overseer and recommended Kayla Holder for the position.
