Street lights have been turned in to Energy for repair but they are behind on repairs because of response to help with hurricane damage in other areas of the country.

The mayor discussed details of the loan and bids would soon be asked for on the project.

The A.N.R.C. LOAN is for \$327,000.00 at 1.75% and an early payoff of the loan is possible.

Mayor James read a letter from city attorney Johnny Dunigan stating his opinion about the proposed R.V. park that Ricky Smith had asked the council about putting in at last month's meeting. Dunigan stated that this park would violate the present ordinance allowing one mobile home per lot with an R.V. meaning defined as a mobile home. He further stated that granting a variance could result in opening the city to lawsuits.

After discussion by citizens on the matter, no motion was made to allow the park and the council will stand with the
