Mayor James said the two checks have not been cashed are in holding till the council makes a decision on which party will get the use of the building. The council agreed to table the decision until next month allowing foe time to gather more information on the situation.

Mayor James also gave an update on the new well drilling progress.

The well has reached a depth of 850 feet at this time, with the well casing going in soon.

Work on the water tank coutinues to progress with both cleaning and painting going on inside and outside the tank. All of the work is being paid for with money from a grant.

There is no new news on the Flood Zone and the insurance associated with it.

Daniel Haynes was hired last month to mow and weedeat the city cemetery.

Marvin Browning informed the council of a problem occuring at the city pond with the turtles.
