Cameron Tate will be hired to overlook the city sewer plant and train city employee's to do the job. The city will pay Cameron \$100.00 a week to do this. He is already being paid \$100.00 a week to do the water side.

Arkansas Rural Water will have people providing training also.

Jerome will also be here to provide training for Roger and Jerry.

Roger Overman and Jerry Berry will be attending classes to take the test to attain the license they need to operator the city sewer system.
