The mayor informed the council that the budgets for General, Street and Water departments included a one dollar an hour increase for all employees.

Mayor James also stated the mayor's salary is \$900.00 per month, city recorder/treasurer salary is \$750.00 per month and all aldermen make \$100.00 per month.

The mayor gave a update to the council on state funding for street repairs planned for later this year. The \$300,00.00 will help pave Kentucky, St. Louis, Chicago, Bowen and Payne streets.

Mayor James informed the council of plans to purchase a new mini-excavator priced at \$89,863.00. Bids for the piece of equipment will be gathered by the February meeting. Also prices for the purchase of two new trucks, one for the Water Dept. and one for the Street Dept. will be gathered.

There was some discussion on the city's employee sick day policy.

The roof at the Senior Life Center is leaking and the city is working with the insurance company about the repairs needed.

There are many street lights out in town and the mayor said he would get with the night police officer about gathering a list of them for repair.

There was some discussion about a cemetery plot's condition.

The mayor said he is still working on getting someone to repair siding on the fire department building.
