AMENDING TITLE 8, CHAPTER 8.04, SECTION 8.04.01

AN AMENDED ORDINANCE REGULATING INATTENTIVE DRIVING IN THE CITY OF CARAWAY, ARKANSAS.

AN ORDINANCE AMENDING TITLE 8, CHAPTER 8.04, SECTION 8.04.01.

WHEREAS, the City Council of the City of Caraway, Arkansas (the "City"), has previously passed an Ordinance codified at Section 8.04.01 regarding Inattentive Driving; and

WHEREAS, the purpose of this Ordinance is to amend certain provisions of Section 8.04.01,

WHEREAS, it is previously been determined that an ordinance was needed to deal with circumstances regarding the orderly regulation of traffic upon the streets, alleys, private property, and highway within the City of Caraway, Arkansas;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Caraway, Arkansas:

That Code Section 8.04.01 is amended as follows:

- A. It shall be unlawful for any person to drive any motor vehicle upon the public way or upon any private driveway within the City of Caraway, Arkansas, in an inattentive manner.
- B. An inattentive manner of driving is defined as the operation of any motor vehicle on the public way or private way of the City of Caraway, Arkansas, while failing to give reasonable regard or attention to the act of driving or operation of such vehicle.
- C. Any such person adjudged guilty of violation of this section shall, upon conviction, be fined in the amount of not less than Fifty Dollars (\$50.00) nor more than Two Hundred Fifty Dollars (\$250.00).

EMERGENCY CLAUSE: Due to the immediate need for alternative traffic enforcement procedures, and in the interest of the health and safety of the citizenry of Caraway, Arkansas, an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage.
