The council discussed replacing the sidewalk beside the Caraway Methodist Church. City employees will look into the work.

Caraway Car Show will be on main street Saturday, April 22rd.

Caraway Easter Egg Hunt will be Saturday, April 13th, at 1:00 p.m.

Clean up of old tires on property served with the city clean up ordinance were discussed.

Repairs needed on the factory building were discussed.


Repair of tile flooring at the Caraway Community building was discussed.
